













KEY PROGRAM DATES

On March 25, 2021, the Emergency Food and Shelter Program (EFSP) National Board notified Local Boards and State Set-Aside (SSA) Committees by email of the pending application schedule for the American Rescue Plan Act of 2021 (ARPA), Humanitarian Relief, funding, **starting in mid-April**. On April 12, 2021, the **ARPA Guidance**, was posted to the EFSP website under the Supplemental Funding Info tab. The confirmed application schedule as found in the **ARPA Guidance** is as follows:

ARPA Humanitarian Relief Application: The ARPA Application is available on the EFSP website under the Supplemental Funding Info tab. The National Board will notify Local Boards and SSA Committees (acting as Local Boards) via email when the application is available on April 19, 2021. The application will be available for each application period indicated in the table above. Local nonprofit, faith-based, and government organizations interested in applying for reimbursement of eligible expenses incurred in providing services to families and individuals encountered by DHS may apply.

Service organizations will submit their applications to their respective Local Board for the jurisdiction (county or city) in which they provide services. If an organization is seeking funds in more than one jurisdiction, a separate application must be submitted to each Local Board of the respective jurisdiction. State-wide organizations that provided eligible services may apply through their SSA Committees. Organizations may access Local Board and SSA Committee contact information by clicking on the **Supplemental Funding Info** tab via the EFSP website. On the EFSP website, service organizations complete their applications and electronically submit them to their respective Local Board or SSA (acting as a Local Board).

ARPA Special Funding Request (SFR): The ARPA SFR is accessed via the Special Funding Request portal on the EFSP website to apply for these supplemental funds. To submit an SFR, Local Boards and SSA Committees (acting as a Local Board) will log-in with their user ID and password and click on Supplemental

Funding Special Funding Request from the menu on the left to access the portal. If interested, <u>organizations</u> may inquire of their respective Local Board or SSA Committee (acting as a Local Board) about requesting funds in advance of services provided via the **SFR** process.

Local, nonprofit, faith-based, and governmental organizations interested in receiving funds must ensure their supporting documentation (spreadsheets, daily logs/schedules, proofs of purchase, as necessary) are prepared and submitted to their respective Local Board or SSA Committee (acting as a Local Board) by the deadline. <u>Local Boards or SSA Committees (acting as Local Boards) will determine the schedule for organizations to submit their information that will be included in the jurisdiction's SFR to the National Board.</u>

Competitive Grant Process

This is a competitive grant process, so no application or SFR is guaranteed an award. Priority will be given to communities deemed to have been most impacted by this humanitarian crisis. Based on the level of demand, an award may be less than the full dollar amount requested, although the full amount is for eligible expenses.

IMPORTANT: Failure to meet any program deadline will cause applications and SFRs to not qualify for funding or risk cancellation or delay of payment, if awarded funds.
